2012- Warrant article to calm traffic - failed

2018 – Town applied for grants – given to larger towns

2021- Warrant article - failed

2022- Planned to get engineering design completed – fell by the wayside

2024- Charrette proposals gaining momentum – should be in Master Plan

We need a traffic study by Town and by DOT.

May need private donations for design and grant for construction
